- (g) The below mentioned Basic Price includes EDC, IDC, Open Car Parking, PLC, Power backup. Registration charges or any other charges will be as specified in the Agreement.
- (h) That the allotment of Apartment is at the sole discretion of the company and the Company has the right to reject any offer / application without assigning any reason. In that case the Company will refund the Booking Amount along with interest at the rate of 8% p.a.
- (i) If there is any additional levy, rate or charge of any kind attributable to the Apartment, as a consequence of any order of Government / Statutory or other Local Authority if applicable, shall be payable by me / us on Pro-rata basis.
- (j) In case the Applicant(s) / Intending Allottee(s) gives a written notice to cancel the allotment then in that event the Company shall cancel the allotment and after deducting 20% of the total cost of the said unit along with overdue interest from the amounts received from the Applicant(s) / Intending Allottee(s) till that date refund the balance amount to the Applicant(s) / Intending Allottee(s) within 90 days from the date of such cancellation.
