

Plan chosen by each member and shall give reasonable time of at least 30 days for payment from the date of issuance of such demand letter. The member shall abide by such demands which shall be made from time to time. If any member defaults in honouring such demands then Revanta Multi State shall be at liberty to terminate his/her membership from the Group Housing Scheme by giving him/her a notice to clear his/her backlog of payment with interest @ 18% p.a. within a period of 60

days from the date of issuance of such notice.

Payment Schedule

- (i) 30% of Land Cost at the time of becoming housing member.
- (ii) 30% of Land Cost within 30 days of becoming housing member.
- (ii) 40% of Land Cost within 60 days of becoming housing member.

Plan II

- (i) 25% of Land Cost is to be paid at the time of becoming housing member.
- (ii) 25% of Land Cost is to be paid within 30 days of becoming housing member.
- (iii) 25% of Land Cost is to be paid within 60 days of becoming housing member.
- (iv) 25% of Land Cost is to be paid at the time of Land Transfer Certificate (LTC).

Surrender of Membership

A member can surrender their membership by written application and the amount shall be refuned as follow:

Share Money: Rs. 1000

Refund: Full amount including Land Cost, Construction Cost etc, shall be refunded to the member as and when any new member replaces him/her.

Transfer: The member can transfer his/her membership in the Group Housing Scheme without any interest/appreciation without paying any charges.


DECLARATION

- (4) That I will not make any default in payment of any amount to be paid to the Revanta Multistate Co-operative Group Housing Society Ltd under the bye-laws of the Society in case of default I will cease to be member of the Society and the decision of Revanta Multistate Co-operative Group Housing Society Ltd in this regard shall be final and binding.
- (5) That I am major, an individual and competent to contract under section 11 of the Indian Contract Act, 1872 (9 of 1872).
- (6) That I will purchase the minimum number of shares and pay the value thereof in full as may be laid down in the bye-laws of the Revanta Multi State Co-operative Group Housing Society Ltd.
- (7) That I will fulfill all other conditions laid down in the Act, the Rules and the bye-laws of the Revanta Multi State Co-operative Group Housing Society Ltd.
